**1. Attendance and Apologies**

**2. Area Reports**

**Fife (John Todd and Lynsey Paterson)**

- Bill Sandell has replaced John Muir as Chair;
- Jayne Allan has resigned as Treasurer;
- The AGM will be held on Sunday 29 May;
- Committee to consist of office-bearers plus delegate from each band;
- The Youth Band has its own committee;
- Hope to introduce a monthly structure to Youth Band rehearsals;
- Infrastructure grant spent on projector, screen and plinth;
- Future plans include a Youth Forum.

**Borders (Nicola Douglas and Angela Douglas)**

- Workshop in September where band was selected for Perth Championships;
- Party to celebrate Perth victory followed by tour of trophy around individual concerts;
- Youth Committee comprises 2 players from each band (aged c.14-17) to ensure continuity;
- Fundraising is being investigated for the possible purchase of uniforms;
- A successful workshop was held in March, with a potential “D” band in September;
- The Borders Entertainment will be Open Adjudication.

**NCBBA (Richard Kidd and Damian Martin)**

- Nothing to report from last May until this April;
- There is a new committee;
- This area faces slightly different challenges because of its geographical spread;
- This year’s contest has been cancelled with a view to rebuilding for 2012;
- Progress is being made for solos and ensembles.

**Edinburgh (Mark Bell and Julie Sanderson)**

- There has been a difficult handover, but a blank slate for progress;
- Support is forthcoming from Midlothian for the Solos on 12 November;
- With over 100 pupils in Midlothian alone, there are geographical difficulties;
- Bands are not involved enough at present.

### **West of Scotland (Carrie Boax and Brian Deans)**

- New office-bearers were elected on 16 May, the first meeting since 2009;
- Some ideas currently under discussion, but funding will be required;
- This is a very large area geographically and in terms in numbers of bands;
- Solos and ensembles will be held on 29 October.

### **3. General Points**

- It would assist SBBA if qualifiers were held before Christmas;
- It was asked if it would be of benefit if SBBA were to bulk buy medals and plaques;
- The creation of “Development Assistants” was mooted, to help the Development Officer drive forward growth in the Areas: this will be discussed with Creative Scotland;
- The SBBA Executive will communicate to the Areas the balance of funding available to them;

### **4. Consistency of Rules**

- Questions were raised about the lack of consistency of rules between Area Qualifiers and Solo/Ensemble Finals:
- Three qualifiers in each section only;
- The Application Form provided by the SBBA Secretary must be used: this will be circulated;
- Concerns were raised over whether a player could be allowed to perform with more than one ensemble at the ensembles event. It has been proposed (and accepted) that, “in each age group, each ensemble may play a maximum of one player who has played in another ensemble within that age group”;
- Forms will be adapted to include the details of players involved in ensembles;
- “Age” is defined “as at 1 January”.
